GENERAL FAIR ADMISSION: Fees will be charged from 10a until 10p daily

DAILY ADMISSION FEE: \$3.00 per person
Children 12 years old & under are FREE

WEEKLY GATE PASS FEE: \$12.00 per person
Entitles one person gate entrance into the fairgrounds each day

LIVESTOCK EXHIBITOR GATE PASS FEE: \$10.00 per person
Pass issued to CCYLP or 4-H Member/Group Leader for the use of that member only.
The Exhibitor's vehicle is allowed entrance through the west gate to service exhibits.
In no case shall any vehicle drive on the midway; must park in designated areas.
This pass does not admit the entire family

RULES & REGULATIONS OF CHEBOYGAN COUNTY FAIR

ARTICLE I : OFFICERS

1. Cheboygan County Fair operated by the Cheboygan County Fair Board will be open to the public Saturday through Saturday.
2. Each Superintendent of the Fair will be in charge of one or more departments who with such assistance as is required will have the exclusive management of the same. Such superintendents will oversee the judging in his/her department and will be responsible for making a report of awards at the close of judging. Each superintendent is responsible for setting up and taking down displays.
3. During the Fair the members of the Fair Board with the assistance of the management team will be ready to address any complaints or protests. ANY Such complaints or protests must be made during the fair.

ARTICLE II : GENERAL RULES

1. The management reserves the final and absolute right to interpret these rules & regulations and to arbitrarily settle and determine all matters, questions or differences in regard thereto. It further reserves the right to amend or add to these rules as in its judgment it may determine to withdraw all, or pay in part, premium offerings in all departments, should an emergency exist and circumstances demand it.
2. Drug Testing Procedure
 - Any animal entered in any class at the fair may be subjected to drug testing. Any accusations of animals being drugged must submit to drug testing. The Fair's veterinarian/authorized representative may collect urine, blood, hair, tissue and/or other test samples as needed. The samples will be collected and sealed in the proper containers and sent overnight express to Michigan Department of Agriculture, Laboratory Division in East Lansing. If the animal is clear of drugs, the person making the accusation must pay testing. The expense for the drug testing shall go to the person owning the animal if the test results show proof of improper use of drugs.
3. Compliant Procedures
 - An aggrieved exhibitor may make a written complaint to the fair within ten (10) days after the Fair ends. The Directors will investigate the complaint and issue a written notice of findings within thirty (30) days after it is submitted to the Fair. If the Fair has not satisfactorily settled the grievance, the aggrieved person may file the complaint with Michigan Department of Agriculture within fifteen (15) days after receiving written notice from the directors. The Department shall have sixty (60) days after receipt of an appropriately filed appeal to investigate the complaint, and issue a finding of fact and notice of department action and recommended actions for the association. There is a \$50.00 filing fee.
4. Any Persons showing signs of intoxication or drinking will be removed from Fairground premises by the Sheriff, Police, or Fair Official. No alcoholic beverages allowed on fairgrounds.
5. The judges of each participating event and the Fair Officials will be in complete control of all events.
6. Persons starting any argument or misconduct at the fairgrounds will immediately be removed from the fairgrounds.
7. The participants will be governed by all rules and regulations set by the Board of Directors of the Fair.
8. Any Organization or anyone selling or passing out literature or demonstrations must stay within their rental area, pay a rental fee and be approved by the board. Any such groups or persons deemed unsatisfactory to the Fair or the promotion or Agriculture or Forestry will not be allowed.
9. These rules are final and will be strictly enforced. Violators, if contestants, will forfeit all entry fees, and be removed from the Fairgrounds.
10. The Fair will be open each day at 10:00a (unless otherwise specified) and all employees and officers on duty that day are expected to be on hand.
 - The carnival will open at 12:00 noon.
 - Exhibit buildings open at 12:00 noon.

ARTICLE III : EXHIBITORS

1. **COMPETITION IS OPEN TO EVERYONE UNLESS OTHERWISE SPECIFIED.**
2. **To insure Cheboygan County participant sovereignty, a youth agricultural or livestock participant must meet one of the following requirements effective August 16th, 2015. This policy applies to youth that are not members of 4-H agricultural or livestock programs as 4-H already has similar participant requirements. A youth is defined as a person under the age of eighteen (18) years of age that meets necessary requirements to safely participate in these programs or events.**
 - a. **The youth must be permanent resident of Cheboygan County for a minimum of at least 9 months prior to the Cheboygan County Fair registration deadline or show evidence that the youth has permanently relocated to this area during that time period and is still able to meet all registration deadline requirements.**
 - b. **The youth must be enrolled at a school located within Cheboygan County or be home schooled at their permanent residence within Cheboygan County.**
 - c. **The youth may request to show just cause to the Cheboygan County Fair Board as to why they cannot meet these requirements but still believe they should be able to participate. The Fair Board will review these requests on a case to case basis and the Fair Board ruling will be final.**
3. **All CCYLP and 4-H Club members wishing to enter OPEN livestock may do so under the same rules and regulations as OPEN Class, as well as being under those CCYLP and 4-H Developmental Committees.**
4. **SEE ENTRY FORM SCHEDULE IN FRONT OF FAIR BOOK.**

6. **See Exhibitor Entry Schedule in the front of the book for days and times exhibits can be brought onto the fairgrounds.**
7. **ALL ENTRIES MUST BE MADE IN THE NAME OF THE OWNER OR OWNERS, OR GROWER OR PRODUCER, WHICH PERSON OR PERSONS SHALL PAY PRESCRIBED EXHIBITORS FEES. SEE EXHIBITOR ENTRY SCHEDULE IN THE FRONT OF THIS BOOK.**
8. **Tags will be furnished by the management with the number, class, etc., upon arrival. Exhibitors must be careful to place these tags upon or near articles or animals so that the judge will have no difficulty in finding them.**
9. **Articles or animals incorrectly entered may be disqualified. Premiums will be awarded according to the judges sheets, not necessarily according to the ribbons on the entry.**
10. **The management will use diligence to insure the safety of livestock and articles to be entered for exhibition or display their arrival on the grounds, but under no circumstances will it be responsible for loss or theft, injury or damage by fire, lightening, wind, or any other acts to such livestock or articles on exhibition or display, and the Fair and Management shall be indemnified by the exhibitor against all legal or other proceedings thereto.**
11. **A VETERINARIAN WILL BE ON CALL BUT NOT NECESSARILY ON THE GROUNDS.**
12. **Entries will be accepted or rejected on the recommendation of the Fair Board or authorized representatives or authorities, with final decision being made by Executive Board and management.**
13. **Every article and animal upon the fairgrounds will be under the control of the Fair Management and every precaution will be taken for their safekeeping, but the Fair will NOT be responsible for any damage or loss that may occur and upon those conditions entries will be received.**
14. **No person should be allow to act as a judge of any class in which he or she is competitor and no premium will be paid to anyone in any way trying to influence the decision of the judges. Do not place name of owner or advertising on any kind of exhibit prior to judging.**
15. **The fair reserves the right to pro-rate premiums if funding is not received from the State of Michigan or if fair receipts are insufficient to pay expenses. Premium checks might not be mailed out until thirty (30) days after the fair ends.**
16. **NO SMOKING IS ALLOWED ON THE FAIRGROUNDS.**
17. **CCYLP and 4-H passes admit CCYLP and 4-H member only, not their family members.**
18. **ALL DOGS MUST BE ON A LEASH; NO DOGS ALLOWED ON MIDWAY OR ANY EXHIBIT BUILDING OR BARN, UNLESS CANINE IS A SERVICE ANIMAL.**
19. **ALL ERRORS IN PREMIUM STATEMENTS OR CHECKS OR OMISSIONS MUST BE REPORTED WITHIN FOURTEEN (14) DAYS AFTER STATEMENT OR CHECK IS RECEIVED.**
20. **At the discretion of the Fair Board, exhibitor classes may be cancelled for lack of entries.**
21. **Every element contained in this Fair book is subject to change at the discretion of the County and/or the Fair Board.**

ARTICLE IV : CAMPING & TRAILER PARKING RULES & REGULATIONS

1. Camping sites will be reserved on a first come, first served basis. Sites will be assigned by Cheboygan County Fair and Campground Superintendent.
2. Camping fee will be \$120 (includes electricity) for the week of Fair or \$15 per night. These fees DO NOT INCLUDE gate entry fee.
3. Camping fee must be submitted with reservation. Starting in January 2015, payment in full is required with your reservation.
4. All trailers must be self-contained, gopher holes will not be allowed, only ONE (1) camper per site.
5. Picnic tables while availability lasts.
6. Camping permit must be displayed on camper where it is visible to all.
7. There will be curfew hours enforced - 12:00 midnight to 6:00 a.m. This means that no campsite will have disturbance or excessive noise during curfew hours.
8. Campsites must be chaperoned by parent or registered guardian 18 years of age or over (with written permission on file in the fair office).
9. Cheboygan County Fair or MSUE assumes no responsibility for any damage or loss of trailers or contents while on the Fairgrounds.
10. Campers may arrive during normal business hours only (8 a.m.-4:30 p.m.) After hours parking by appointment. Campers left in unauthorized spots will be moved at owner's expense.
11. All exhibitors staying overnight at the fairgrounds must be under the DIRECT supervision of a parent or responsible guardian. Written permission from a parent or legal guardian must be submitted to the designated camping superintendent if exhibitor is staying with another non-parent, non-legal guardian adult.
12. All trailers in camping area must be under the responsibility of a parent or registered guardian, 18 years of age or over AT ALL TIMES.
13. Any camper observed consuming alcohol or in possession of illegal drugs will be asked to remove their camper from the Fairgrounds immediately. Proper authorities will be notified.
14. By signing the camping permit application, it is agreed to adhere to all rules and regulations. This is signed permission that designated camping superintendents and Cheboygan County Fair, can and will, have permission to inspect any campsite where there is a disturbance, excessive noise or suspected infraction of camping rules.
15. These guidelines were adopted and will be enforced by both the Cheboygan County Fair and MSUE.
16. NO horse trailer parking between drive and the horse barn and/or side row of trailers and the horse barn or at the ends of the horse barn; these areas are for loading and unloading only. Any horse trailer not parked in designated areas, and/or drawing electrical, and/or water from the barn, will be charged a camping fee.
17. Due to liability concerns, only properly licensed and insured motor vehicles are allowed in the campground area. Personal four wheelers, golf carts and motorized utility vehicles, etc. are forbidden without the express written consent of the Fair Manager.
18. PLEASE PUT ALL GARBAGE IN DUMPSTERS.

ARTICLE V : LIVESTOCK & HORSES

1. Suitable stalls and pens will be furnished for livestock and horses. Each exhibitor will be required to care for, feed and water their animals.
2. Livestock and horses occupying stalls or pens must be entered in the fair and shown in competition when called by judges or be charged \$5 per day for the time the stall is occupied.
3. Grooms and attendants must be neatly and cleanly dressed and must put stalls, pens and floor in a neat and tidy condition by 10:00 a.m. and fed by 6:00 p.m. each day. Feed, straw and bedding to be furnished by exhibitors of livestock and horses.

ARTICLE VI : JUDGING

1. Judges have been given the authority to place less than first premiums on exhibits where only one entry has been made, if in the mind of the judges the exhibit is not worthy of first premium.
2. All articles, except livestock, will be identified by 'exhibitor's number only' during judging. No names or advertising allowed on exhibits until after the same has been judged.
3. No person shall be allowed to interfere with the judge during judging.
4. Premiums will be designated as follows:
First Premium = Blue Ribbon Second Premium = Red Ribbon Third Premium = White Ribbon
THE DECISION OF THE JUDGES IS FINAL ON ALL PLACINGS.

Premium checks will be mailed to winners as soon as possible after the close of the Fair or they will be available to pick-up at the fairgrounds. Checks not cashed within 6 MONTHS will be automatically forfeited to a 'special awards fund'.

EQUINE GENERAL RULES

Equine refers to: Horses, Ponies, Miniature Horse, and Donkey/Mule.

Exhibitors riding Donkeys/mules will be required to show in EQUINE classes. Those who choose to show their Donkey/Mule In-Hand are limited to: Fitting & Showmanship class #6338, Trail class #6371 and Costume In-Hand class #6400 only.

All equine are required to have a current (within 12 months) negative Coggins test. You must leave a copy with your registration in the fair office.

Equine project member's requirements include:

1. 4-H members please refer to State 4-H Horse/Pony Rules and Regulations and the Cheboygan County 4-H Equine Rules and Regulations for complete rules. Copies are available at the Cheboygan County MSUE office.
2. For walk-trot classes: if an exhibitor enters into another gait, it will be a disqualification for the class.
3. All equine project members must complete an Equine Record Book and an interview before Monday's Youth Horse Show.
4. Equine may be brought to the Fairgrounds on Friday if showing in Open Show on Saturday. If not showing in Open Show, all equine projects may be stalled after 5pm Saturday or when the Open Show is finished and stall is cleaned from previous occupant. Sunday check-in deadline is 4 pm. Equine exhibitors must document that their horse has been fed, watered and their stall has been cleaned by 10 am each morning on a chart hung on the outside of their stall. The Barn Supervisor will check each stall to verify that this has been done. Each stall must have emergency information posted. If you leave the grounds, you must designate someone to watch over your horse and post this on your stall. Equines must stay on the fairgrounds until 12:01 am Sunday morning on the closing day of the fair (Exceptions are subject to Fair Board approval and must be made in writing to the Fair Board Thirty (30) days prior to fair week for consideration. Equine exhibitors, including participants in the Tri-County Horse Show, need to include the registration receipt from the conflicting event with their submission. Failure to follow these procedures may result in forfeiture of premiums.)
5. DURING LIVESTOCK JUDGING, EQUINE MAY ONLY BE EXERCISED IN RING #2. Please see judging schedules.
6. For Sweepstakes rules, please see Section 509.
7. Free exercising is allowed, in either arena, at times approved by the Barn Superintendent. All gates must be checked before the animal is lead from the barn and before being released into the arena. The arena must be clear of other animals/exhibitors. There must be constant supervision. Free exercise is limited to one horse or horses who are pasture mates. There is a 15 minutes time limit. NO chasing, yelling, whips or noises to make animals move. Free exercising is done at owner/exhibitor's own risk to equine, self and others.
8. A Fun Show may be held, but no premiums will be given. Only Equine stabled at the fair are eligible to participate. Event will be posted in the barn, along with show times. All safety rules will be enforced during fun shows.
9. No riding except in riding rings and make up rings with the exception of show days in designated areas. Lead horse from barn to ring area. Exhibitor must pick up all horse waste on the grounds outside of riding and make up rings.
10. DISCIPLINARY SYSTEM: to be enacted by the Barn Superintendent, with support from the 4-H Program Instructor, also present will be the youth's club leader and youth's parent/guardian if in 4-H. Offenses will include but are not limited to: unsanitary stalls, not fed/not watered equine, not following safety rules and unsportsmanlike conduct. The system will work as follows:
 - o 1 st Offense - will result in a verbal warning accompanied by a written form titled "Verbal Warning" signed by the above mentioned persons including the offending member.
 - o 2 nd Offense - will result in two (2) additional hours of barn duty and a meeting with the MSUE 4-H representative, the Barn Superintendent, the offending member and their parent/ guardian. The Fair Grounds Manager may be present at his/her discretion.
 - o 3 rd Offense - will result in the loss of ALL earned premiums, inclusive of all disciplines shown. This may also result in being asked to leave the fair grounds for the remainder of the fair or season at the discretion of the Fair Grounds Manager, Fair Board and MSUE 4-H Representative.
11. Patterns - 4-H will be responsible for patterns. Patterns will be completed in a timely manner in order to be included with the Judges Contract packets.

AGE DIVISIONS:

Exhibitors must reach the age of 6 by January 1 st of fair year as required by MDA.

Rider's age is determined by how old he/she was on January 1 st of current year.

4-H EQUINE 5 TO 7 YEAR OLDS RULES:

1. Youth 7 years and under must wear a SEI approved helmet at all times when around horses.
2. 5 - 7 year olds may exhibit an Equine record book, enter in class #8977 and/or Horse - Horseless project book, enter in class #8986 - vet science notebook class #8938 or project feed record book, class #8977.
3. 5 and 6 year olds must remain on a lead line and be accompanied by an adult at all times. 7 and 8 year olds may be walk-trot exhibitors or show in a lead line class with an adult handler. Lead line riders must always be on a lead line.
4. 7 and 8 year olds may participate in walk-trot classes with parent/club leader in the ring with children at all times holding the halter or lead.
5. 5 - 7 year old exhibitors are NOT in any competitive placing classes. They will all receive the same type ribbon and/or award. A comment card from the judge may also be used.

ENTRY FEE: \$ 1.00 per person, per page (no refunds)

LIVESTOCK FEE: \$ 1.50 per stall

PEN FEE: \$.50 per pen (rabbits, poultry, etc.)

STALL FEE: \$ 15.00 per stall for horses or tack. \$10.00 will be reimbursed if stall is clean upon departure. Exhibitor is responsible for any damage to stalls. Tack stalls are subject to availability.

All group members are subject to Cheboygan County Fair General Rules and Regulations. All Cheboygan County 4-H Youth Development Program Policies comply with the State 4-H Horse Show Rules and Regulations. **Special circumstances will be reviewed by an appropriate committee with the approval of the Fair Superintendent.**

1. Department is open to any boy or girl enrolled in a Cheboygan County 4-H or other Youth club, program or group.
2. 4-H members must be registered in project area during current year. All projects exhibited must be the work of the member and be done in the current 4-H year.
3. 4-H exhibitor's age is determined by how old he/she is on January 1 st of the current fair year. CCYLP exhibitor's age is determined by how old he/she is on December 31 st of the current fair year.
4. All livestock and equine entered must comply with State Regulations shown in the front of this book. All members exhibiting animals or poultry that fail to keep animals, stalls and pens in a clean condition by 10:00 am each day may be asked to forfeit their premium. ALL ANIMALS/LIVESTOCK MUST BE CLEAN WHEN THEY ARRIVE AT THE FAIRGROUNDS.
5. Each exhibit must be labeled with an attractive sign bearing the name of the Club/Program that is being represented. Only one market animal per species is allowed, no matter how many market programs the youth is a member of.
6. All 4-H Building exhibits must be in place by noon on the first Sunday of fair. Exhibit tags and admission passes will be available during 4-H Building project check in times (see schedule) and will be given to the member or their club leader.
7. Exhibits may be released between 10:00 am and 12:00 noon on the last Sunday of fair with the exception of livestock and equine, which may leave earlier on Sunday morning. Equine must stay on the fairgrounds until 12:01 am Sunday morning on the closing day of the fair (Exceptions are subject to Fair Board approval and must be made in writing to the Fair Board thirty days prior to fair week for consideration. Equine exhibitors, including participants in the Tri-County Horse Show, need to include the registration receipt from the conflicting event with their submission. Failure to follow these procedures may result in forfeiture of premiums.) Sick or injured animals can be released by order of the Department Superintendent.
8. All exhibitors staying overnight at the fairgrounds must be under the DIRECT supervision of a parent or responsible guardian. Written permission from a parent or legal guardian must be submitted to the designated camping superintendent if exhibitor is staying with another non-parent, non-legal guardian adult.
9. EXHIBITORS CAUGHT USING/CONSUMING ALCOHOLIC BEVERAGES OR SMOKING WILL BE ASKED TO REMOVE THEIR EXHIBIT.
10. Dates and hours for use of wash rack and arena will be posted in all barns for all livestock. Hours posted will be adhered to except for veterinarian or for safety reasons which will be determined by animal superintendents.
11. These guidelines were adopted and will be enforced by the Cheboygan County Fair, Cheboygan County 4-H and CCYLP.
12. 4-H members may exhibit a 4-H project in a Michigan fair only one time.
13. YOUTH helmet rules (4-H youth are ages 5 to 19) during the fair: helmets must be worn by all youth riders any time they are on a horse. During show events 4-H helmet rules apply. Open Show is at the discretion of the Event Coordinator.

MARKET ANIMAL RULES

1. Only Cheboygan County Market Club animals will be sold at the Youth Auction.
2. Market animal weights will be determined at scheduled weigh-in. Leave class number blank but fill in all other information. Any animal not meeting weight requirements will be allowed to show in Showmanship classes including Record Books, but will NOT be eligible for Market Class. CCYLP will not be responsible for sale of underweight livestock. Member must own livestock and small animals, and show own animal. Market animal may not show in any class other than market class.
3. Cheboygan County Grand Champion and Reserve Grand Champion Markets Animals must sell at this time. If an animal from another county is chosen Grand Champion or Reserve Grand Champion, the judge must also pick a Grand Champion and Reserve Grand Champion from Cheboygan County.
4. In order for a youth to sell their animal at the livestock auction an animal must be shown and placed in a market animal class and showmanship during fair.
