GENERAL OPERATIONS, RULES & REGISTRATION

>>REGISTRATION BEGINS AT 3:00P<<
>>PIT GATE CLOSSES PROMPTLY AT 5:00P<<
>>COMPETITION STARTS AT 6:00P<<

REGISTRATION (AT GATE) : \$20

- AFTER COMPLETING TECH INSPECTION AND SIGNING WAIVERS, THE DRIVER IS TO TAKE HIS/HER VEHICLE TO THE STAGING AREA. NO PASSENGERS ALLOWED!
- WHEN THE VEHICLE HAS BEEN CHAINED DOWN, THE STARTER WILL ASK FOR A "THUMBS UP" TO INDICATE THE DRIVER IS READY. STARTER WILL ACTIVATE TIMER AND PARTICIPANT WILL HAVE A CERTAIN TIME, DETERMINED BY THE JUDGE, TO COMPLETE BURNOUT. ALL VEHICLES WILL BE GIVEN THE SAME AMOUNT OF TIME. AFTER THE HORN IS BLOWN/ARM TETHER PULLED THE PARTICIPANT MUST STOP IMMEDIATELY. FAILURE TO STOP WILL RESULT IN AN AUTOMATIC DISQUALIFICATION.
- WINNERS ARE DETERMINED BY JUDGE, INFLUENCED BY CROWD RESPONSE.

RULES

1. PARTICIPANTS MUST BE AT LEAST 18 YEARS OLD AND HAVE A VALID DRIVER'S LICENSE.
2. ALL VEHICLES MUST HAVE FOUR WHEELS
3. NO BALD, CORDED, OR BADLY WORN TIRES WILL BE ALLOWED. HUB CAPS MUST BE REMOVED.
[NOTE: RACING SLICKS ARE ALLOWED]
4. VEHICLES MUST PASS A BASIC TECHNICAL INSPECTION FOR SAFETY.
5. VEHICLES MUST BE KEPT IN CONTROL AT ALL TIMES. IF THERE IS EXCESSIVE TIRE HOP, THE VEHICLE MUST BE STOPPED.
6. OFFICIALS HAVE THE RIGHT TO STOP ANY VEHICLE AT ANY TIME.
7. NO PASSENGERS ALLOWED.
8. NO WATER, SUBSTANCES OR OTHER CHEMICALS PERMITTED ON TIRES.
9. NO FLUID LEAKS OF ANY TYPE PERMITTED.
10. NO ALCOHOL OR DRUGS PERMITTED. THIS POLICY WILL BE STRICTLY ENFORCED. PRESENCE OF ALCOHOL OR DRUGS WILL AUTOMATICALLY DISQUALIFY THE DRIVER AND VEHICLE FROM THE COMPETITION. ANY PARTICIPANT WHO REFUSES TO TAKE A BREATHALYZER TEST, OR FAIL TEST, WILL BE DISQUALIFIED IMMEDIATELY BY THE TECH INSPECTOR.
11. ALL DECISIONS OF THE TECH INSPECTOR ARE FINAL.
12. ALL VEHICLES MUST BE CHAINED DOWN
13. CHEBOYGAN COUNTY FAIR BOARD WILL NOT BE HELD RESPONSIBLE FOR PERSONAL OR PROPERTY DAMAGE DURING THE EVENT
